### INITIATED LAWS AND RESOLUTIONS

1854

Statement to International Organizations and Institutions on Recognition of the Russian Federation as an Aggressor State.

1788

Enforcement of Ukrainian judicial system by creating constitutional prerequisites for acknowledging of International Criminal Court jurisdiction on the basis of conditions covered by the Rome Statute.

1769

Amplification of authorities of regional, Kyiv and Sevastopol state administrations on protection of ecological network and creating new conservancy areas.

1861

Harmonizing transfer price formation with international practice. It will favor further economic recovery and rise in business activity.

1736

Statement to the International Community on Mass Shooting near Volnovakha.

1887

Statement to the International Criminal Court on Acknowledging the International Criminal Court Jurisdiction by Ukraine with the Object of Conducting an Independent Investigation and Bringing to Justice of Persons Liable for Crimes Against Humanity and War Crimes on the Territory of Ukraine.

Amendments on prohibition of the Russian Army and FSS (Federal Security Service) propaganda and other Russian film products on TV and film distribution and exhibition system.

### ESTABLISHMENT OF INTERNATIONAL RELATIONS AND IMPROVEMENT OF IMAGE OF UKRAINE

Held a meeting with the Republic of Estonia MFA delegation during which defined intensifying of inter-parliamentary dialogue as a top-priority task.

Held a meeting with the Leader of the European Commission "Support for Ukraine" Group Peter Balas. Discussed actual state and perspectives of promotion cooperation between the EU and Ukraine.

Initiated a roundtable meeting between committees on the topic "The Rome Statute Ratification and Joining of Ukraine to the ICC".

Held a meeting with a delegation of MPs from Georgia.

Together with the Republic of Lithuania Seimas MPs defined a top-priority directions of Ukraine-Lithuania bilateral relations.

Held a meeting with PACE delegate from Germany Marieluise Beck, member of the Greens Party.

Supported work of the Ukrainian PACE delegation during the Winter Session.

Held a meeting with Ambassadors of Vietnam, Georgia, Italy, Latvia, Germany, the Czech Republic, Sweden.

### STRUGGLE FOR THE REFORMS

Organized a meeting of MPs with representatives of the Executive Committee of the National Reform Council and EBRD management.

Took part at Kyiv International Economic Forum.

Held a meeting with the RAND Organization representatives.

### CIVIL DUTY

Organized a meeting of volunteer organizations representatives with representatives of the International Republican Institute, which was aimed at joining efforts and comprehensive help for those children, who lost their parents because of Russian military aggression. Money for the families of servicemen was transferred.

Held a meeting of public and business sectors for joining their efforts in a post-war reconstruction of the Donbass region.
