INITIATED LAWS

2558

Condemns Nazi and communist totalitarian regimes and bans propaganda of their symbols.

2629

Establishes moratorium on construction works in parks, alleys of Kyiv, on banks of the Dnipro river and near historic monuments.

2696

Makes important for public databases accessible for citizens and establishes transparency of registration procedures.
